

AGREEMENT

3. Claiming CME Credits

4. Misconduct & Security

Organizer reserves the right to evict or ban any participant whose conduct is objectionable for any reason.

Security is not provided; therefore, Organizer does not assume responsibility for damage to, loss of, or theft of property.

5. Liability & Indemnification

Participant shall defend, indemnify and hold harmless the Orthopedic Shoulder and Elbow Foundation, Paséa Hotel & Spa, and each of their officers, directors, employees, agents, and representatives from any losses, liabilities, damages, demands, suits, causes of action, judgments, costs or expenses (including court costs and reasonable attorneys' fees) arising out of or due to (a) the attendance of Participant at the OC Shoulder; (b) the negligence or willful misconduct of Participant, or their representatives; or (c) Participants' breach of any commitment made in this agreement.

6. Cancellation Policy

Participant agrees to inform the organizer at tina@ocshoulder.org as soon as possible if they are no longer able to attend. **No-shows are obvious given the assigned seating and intimate group setting. Registration fees are refundable until Monday, June 9, 2025.** Thereafter, refunds will only be awarded if the organizer is able to replace the participant with someone on the waitlist. A 2.9% fee may apply to all transactions.

Organizer may cancel this event and will not be liable for the fulfillment of the delivery of a CME activity if non-delivery is due to any circumstances beyond the control of the organizer, such as, but not limited to, the facility being unfit or unable, fire, pandemic, an act of God, unavailability of utilities, public emergency, the act of war, strikes or labor dispute, or authority of law, or postponement, or cancellation by the organizer. The organizer will, however, in the event of not holding the event for any of the above reasons, reimburse participants for any amount paid in, less all reasonable expenses incurred, such as but not limited to, rent, advertising, operating costs, etc. or offer the opportunity to roll the amount paid into a future year's event.
